ORDER

WHEREAS, WRC, NCTE had granted recognition/permission to SHAHEED NARENDRA SINGH COLLEGE, SUGAR MILL COMPOUND, JAORA, RATLAM- 457226 MADHYA PRADESH vide order dated 10-06-2004 to start the B.ED. (CO-ED) Course with an annual intake of 100 students.

AND, WHEREAS, Shri Pawan Dubey filed W.P. No 2370/2012 (PIL) in the Hon'ble High Court at Jabalpur. The Hon'ble Court directed NCTE to conduct inspection of all B.Ed. institutions in the State of Madhya Pradesh.

AND, WHEREAS, the letter for submission of AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015. The institution submitted affidavit vide letter dated 03.02.2015.

AND, WHEREAS, Revised Recognition order was issued to the institution on 31.05.2015.

AND, WHEREAS, the Inspection (U/s-13) was conducted by NCTE Hqrs. on 06.01.2015.

AND, WHEREAS, the Deficiency Letter was issued by the NCTE Hqrs. to the institution on 11.05.2015 and the reply of Deficiency Letter was submitted by the institution to NCTE Hqrs.

AND, WHEREAS, the VTR along with file of the institution were received from NCTE Hqrs. in WRO on 12.11.2015.

AND, WHEREAS, the matter was placed in 235th Meeting of WRC held on November 23-24, 2015 and the Committee decided that "... NCTE Hqrs. conducted inspection u/s 13 of the NCTE Act, 1993. WRC examined the replies given by the institution to the recommendations made by the NCTE Hqrs. It is seen from the reply that

(i) The classrooms are of dimensions which are less than as required in the NCTE norms;

(ii) The institution is required to submit staff list as per NCTE norms approved by the affiliating body; and

(iii) The institution is required to submit evidence of having paid the staff as per approved pay scale, as well as provisions of benefits.

Hence, Show Cause Notice u/s 17 be issued to the institution on the above grounds."

AND, WHEREAS, the Show Cause Notice was issued to the institution on **08.12.2015** and the reply of Show Cause Notice was received on **11.01.2016**.

AND, WHEREAS, the matter was placed in 246th Meeting of WRC held on March 16-18, 2016 and the Committee decided that "... Consequent to the consideration of the reply of the institution to the points raised after inspection under Section 13, the WRC had issued a Show Cause Notice on 08/12/2015. The institution vide reply dt. 11/01/2016 has given the following responses:

- i) It has mentioned the sizes of the Classrooms which are adequate. However, the Certificate from the Govt. Engineer to this effect needs to be submitted.
- ii) The institution has not submitted the staff profile on NCTE proforma, duly approved by the Registrar of the affiliating University.

Hence, Clarification be obtained on the above two grounds."

AND, WHEREAS, letter seeking Clarification was issued to the institution on 21.03.2016 and reply was received on 12.04.2016.

AND, WHEREAS, the matter was placed in 252nd Meeting of WRC held on May 09-10, 2016 and the Committee decided that "... Clarification letter was issued on 21.03.2016 asking the institution to submit a certificate from a Govt. Engineer regarding the size of the classrooms. The institution has submitted a certificate signed by the Sub-Engineer, M.P. State Agriculture Marketing Board who is not competent. The certificate should be signed by a PWD Engineer.

Secondly, the institution has submitted a photocopy of the staff profile approved by the Registrar of the affiliating University. The originally approved list is required.

The institute should comply with the above before 30th May, 2016."

AND, WHEREAS, the letter was issued to the institution on 18.05.2016 and the reply of letter was received on 31.05.2016.

AND, WHEREAS, the matter was placed in 254th Meeting of WRC held on June 07-09, 2016 and the Committee decided that "... Clarificatory letter was issued on 18/05/2016 and reply was received on 31/05/2016. The institution was asked to submit the Building Completion Certificate by a PWD Engineer and originally approved list of staff. As per revised order dt. 31/05/2015, issued for an intake of 100 students (2 basic units of 50 each), the institution was required to submit a list of one Principal and 15 faculty members. However, it is seen from the file that the institution has submitted a list of only one Principal and 7 faculty members. Further, 29th of February, 2016 was the deadline for submission of the approved staff list, as per intake in the revised order.

Hence, the Committee decided that the intake of the institution is reduced to one unit of 50 students from the session 2016-2017."

Now, therefore, the intake of the institution for conduct of B.Ed. course is hereby reduced from two units of 50 students each to one unit of 50 students from the academic session 2016-2017.
